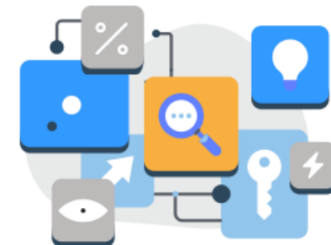

# Child Support

Never married or divorced parents who have minor children must ask the court to decide which parent will pay child support, how much will be paid, or if a change can be made to the current payment. Look through our self-help forms, videos, and linked resources on Child Custody in Indiana.

## Forms

### Extend Child Support for 19 Year Old HS Student

This form can be used if you want to ask the court to require that child support be paid until child (age19) graduates.

### Change Child Support When Child is Emancipated & Parents Agree

This form can be used to ask the court to update child support because one of your children has been emancipated.

### Change Child Support When Parents Do Not Agree

This form can be used if you are a parent and want to change child support when the other parent disagrees.

### Change Child Support When Parents Agree

This form is used if you want to change an existing child support order and you and the other parent agree.

# Change Child Support When Parents Do Not Agree

This form is helpful if you want to change your current child support order and the change is NOT because your child should be emancipated. This form should only be used when you and the child’s other parent do not agree on changing the current order.

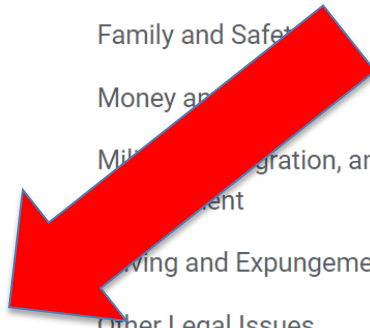

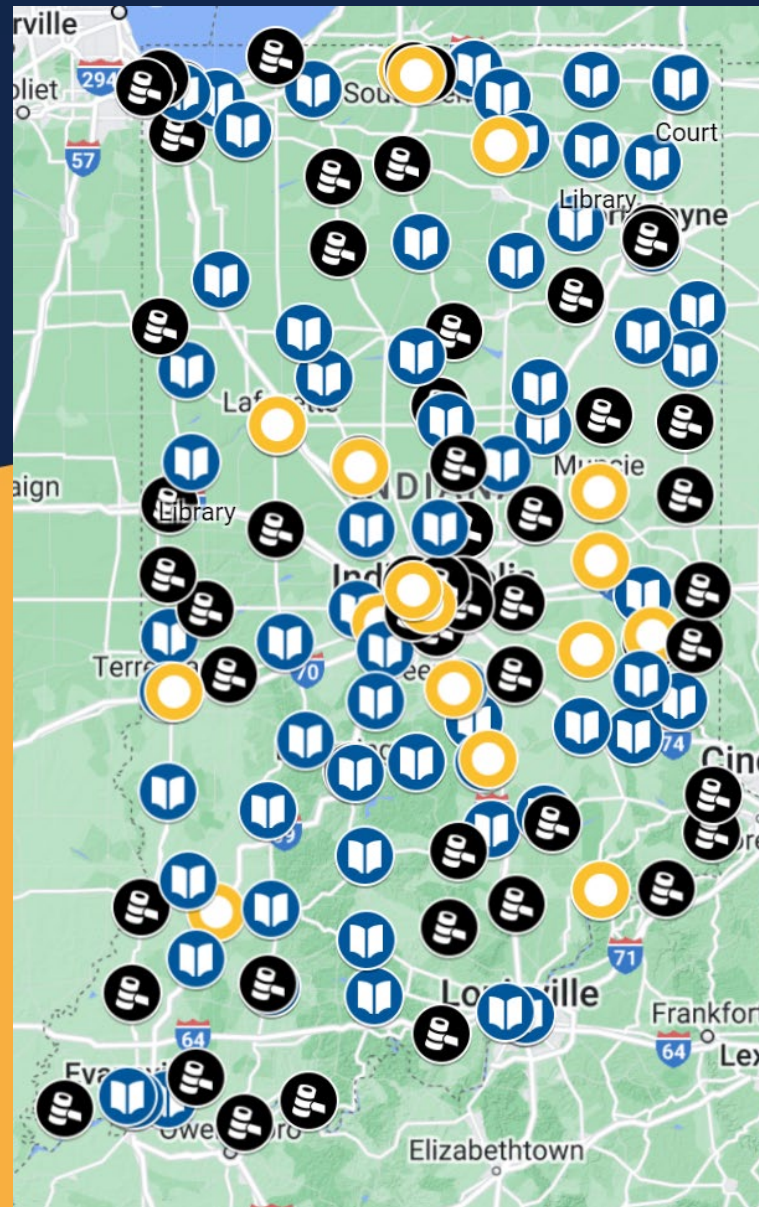
