Odyssey Case Management System

- Data entry point for all court related data. Court and clerk staff work in Odyssey and that data then populates to other publicly accessible systems
- Odyssey used in all 92 counties
 - 9 counties use a different system for Juvenile cases
 - Allen, Howard, Johnson, LaPorte, Lake, Madison, Porter, St. Joseph, Tippecanoe
 - 6 city/town courts use a different case management system
 - Batesville (Ripley), Clinton City (Vermillion), Hagerstown (Wayne), Martinsville (Morgan), Mooresville (Morgan), Portland (Jay)

 Attorney Dashboard

- Public cases. Some cases are not accessible online to the general public (i.e. Adoption, Mental Health, Juvenile, Protection Order, most expunged criminal cases)
 - CCS this is the entries that happen on a case like motions and order entries.
 - Documents a task force chaired by the Chief Justice reviewed case type by case type to determine if documents should be available online. The goal was to make as much available as was safe to do so.

- Additional text below that is an event comment and may be inconsistent based on user entry
- If an entry has the document icon beside it and appears blue, the document is publicly available.
